Representation Review - Consultation

Last week on Wednesday, 14 August, Council reaffirmed the decision to introduce Māori wards which was made on 22 November 2023.

Councillors agreed unanimously to reaffirm their decision for Māori Wards to honour their commitment to this community, and to proceed with the consultation underway with the representation review.

The decision was required after the government's new Local Government (Electoral Legislation and Māori Wards and Māori Constituencies) Amendment Act 2024 became law last month.

This Act restores the provisions for a poll or referendum on Māori Wards and will mean that as part of the 2025 election, Council will hold a binding poll (referendum) asking if Māori wards should stay in place for the next two elections (2028 and 2031) or not.





Freedom Camping Bylaw Review - Consultation Open

Council is proposing the reviewed Draft Freedom Camping Bylaw to manage freedom camping within the Kawerau District, while protecting the environment, and addressing concerns around health and safety.

The consultation process is asking the community....

- Whether people support the new proposed restricted and prohibited sites? This would mean:
- Prideaux Park continue to be an area for selfcontained vehicles; but extend current restricted area to include the grassed area along the northern side of the Kawerau Bowling Club;
- Maurie Kjar Aquatic Centre carpark- reducing the area overall;
- Firmin Field reducing the area for freedom camping to provide better parking for hirers of Firmin Lodge and to ensure the public toilet facilities can manage;
- Ron Hardie Recreation Centre now prohibited due to health and safety concerns with Sulphur levels;
- Do you agree with prior approval for freedom camping in self-contained vehicles
- Do you agree with 7 nights total being allowed in the Kawerau District in one calendar month?

- Do you agree with the introduction of obtaining prior approval to freedom camp in non-self- contained vehicles and tents, within the restricted area/s of:
- Waterhouse Street Reserve
- 2 Firmin Field (on the field itself)
 (Would only be permitted in conjunction with the hireage of Firmin Lodge due to the capacity of the infrastructure (public toilets)

Rates Rebates Applications

Rate rebate applications are now open for the 2024/25 rating year. The maximum rebate allowed is now \$790. To qualify for a rebate the following criteria apply:

- You must be the legal ratepayer for the property.
- The property is your usual place of residence as of 1 July 2024.
- The property is not used principally for commercial, industrial, business or farming purposes.
- You must apply between 1 July 2024 and 30 June 2025.

The Rates Rebate Scheme is a DIA (Department of Internal Affairs) funded scheme designed to benefit homeowners on low incomes.

Dog control

In July, the dog rangers responded to 92 service requests.

- 16 jobs over the last month have been related to kennel checks, microchipping, releasing dogs from the pound and infringement enquiries
- 60 service requests were related to roaming, barking and attacks

During the past month, there have been a few issues involving attacks on people and animals. Handled on a case-by-case basis, these issues have resulted in some dogs being impounded or surrendered, warnings being issued to owners and property inspections being completed. One out of six dogs impounded in July was returned to their owner.

Winter earthquake preparedness

Earthquakes are not any more likely in cold weather, but if you had to evacuate right now, it would be important to have warm clothes and waterproof gear in your grabbag. If you were stuck without power, think about how you would keep yourself and the whānau warm. It is a good idea to pull the curtains and put on an extra layer straight away - do not wait until you are freezing. If you use a car, what would you need if you were unable to get home? Warm gear, water and snacks are always good to keep in the boot.
