## **Mobile alert**

On Sunday 26 May as a part of a national test of the emergency mobile alert system most people throughout New Zealand received an alert on their phones.

The test is a good opportunity for us all to think about how we could prepare for a natural emergency.

This is always a good reminder that we need to have an emergency plan for our whānau in the event of a natural disaster such as an earthquake in our rohe, or nearby.

#### Having a WHĀNAU PLAN is important to be prepared; a plan means:

- Have emergency supplies ready (water, food, torches etc.)
- Check out your home and fix and secure shelving, bookcases and anything that may topple over and injure one of your whānau in an earthquake. This reduces the risk of injuries in an earthquake
- Remember to check in on loved ones after the shakes.
- Check for your own injuries
- Try and stay calm, group together with your family, if people panic it may create additional hazards (i.e., jumping in a vehicle and speeding)
- Check in on whānau and neighbours ensure they know what to do and they are ok
- Wait and follow instructions from emergency services

# Proposed Rate Remission Policy



#### Sport, Recreation, and Community Organisations leasing Council land

A rate remission refers to a partial reduction in the amount of rates you have to pay. The rates remission can function in different ways by either reducing the amount owing or waiving the collection of rates altogether.

The reason for the proposed policy is to provide a fair and equitable basis for clubs, organisations and sporting (non-commercial) to pay for services provided by Kawerau District Council.

The objective of this policy is to facilitate the ongoing provision of sport, recreation, and community opportunities for the residents of Kawerau by ensuring that the general rates charged to sporting, recreational, and community organisations that lease Council land are on the same basis as if Council was providing these services. This objective to remit the general rate is provided for under the Local Government Act 2002 and the Local Government (Rating) Act 2002.

Council is seeking feedback from the community about this proposed policy – visit the Council website for more information or call into the Council Office. Submissions must be received by 5pm Wednesday 12 June 2024.

# Thank you, Annual Plan submitters

At the Extraordinary Meeting on 22 May 2024 Council received 59 submissions. Six submitters indicated they wished to speak to at the Hearing, albeit one submitter gave their apologies.

# Day in the life of a dog ranger

#### Dogs, livestock, chickens and ... streets?

Our Dog Rangers focus on educational and proactive measures rather than reactive ones; however, sometimes further action must be taken. When they see a roaming dog, they locate the home and educate the owner on safe dog practices. Our dog ranger will then complete a property inspection to help prevent further occurrences.

Our dog rangers look after more than just dog issues in the rohe; they also ensure there are no hazards or broken signs/streetlights around the area. Our dog rangers maintain a routine approach of logging service requests through the Antenno app and following up with patrols to ensure work is completed. Our dog rangers also monitor and report on areas where frequent incidents occur such as vandalism, willful damage to parks and roaming dogs.

#### How to report dogs

Our dog rangers patrol most streets in Kawerau twice every day, however we are grateful for the assistance of the community through being our eyes and ears. Notification of concerns, inquiries and feedback can be made via:

In September 2023, during the Early Engagement for the Long-Term Plan, Council asked the community what their preferred method of contact is by Council.

The results showed 60 percent of people prefer printed communication.

The newsletter is designed locally and printed in-house and delivered by community groups KADAP (Kawerau and District Ageing in Place) and Tarawera High School students turnabout each fortnight.

# How to report on the Antenno app

**Step 1:** Download the app- download the Antenno app from the Google play store or the Apple App store. Click install and allow access to location, photos and camera.

**Step 2:** Add places to your app. This could be your own address, your workplace or anywhere personal to you. You can then give these places nicknames.

#### You can now start reporting.

In the app, along the bottom, select the 'REPORT IT' tab. Then click on the plus (+) sign to begin a new report.

Scroll through the list to find the best report type for you and select it.

Next you can add up to 3 photos. Please, only add photos if it is safe to do so.

The next tab is the location. Here you will let Council know where the issue is located. Simply enter the address of the location or select a location on the map.

The last tab is where you will add more information. This is where you can describe the issue in further detail. Here you will also add your contact details so you can be updated on the issue. Once you have done that click next and your report will be sent to Council.



### **COUNCIL BRIEFS**

#### Survey findings show no impact

The results of the five-yearly environmental impact survey of the Council Wastewater Treatment Plant on the Tarawera Awa have been completed.

The survey was completed by the Bay of Plenty Regional Council as part of our resource consent and the great news is that there is no impact on the Tarawera River from the discharge.

#### **Expect delays with River Rd works**

Please note that the work has now started on the 400m section of River Road around Transfer Station Road. This area has been plagued with groundwater issues after the massive rainfalls of the 2022/2023 summer. Work is expected to be completed in early July 2024.

There will be traffic management control in place as the work progresses.

Please accept our apologies to residents and users of River Road for any delays.



#### **Ron Hardie Rec Centre repairs**

Last week, contractors began the repairs of the Ron Hardie Recreation Centre roof.

Due to the height and contour of the roof, this had taken some time to find contractors willing to do the work!

This is being completed to ensure the centre can continue to be utilised by the community.

Council is also undertaking a review of the centre to check on the structure, foundations and general state. This will help Council plan for the future in terms of the budget required.

#### **Colder pools**

The pools are running at a colder temperature than usual.

The reason for the lack of steam may be due to the recent weather and also may be due to a build-up of silica that constricts the bore hole. Specialist well-drillers who initially drilled this new bore have advised they can drill down the existing well to try and remove any build-up of silica.

Once the well-drillers are on site, they will investigate every option to ensure the beautiful Maurie Kjar Aquatic Centre is back up and running at full capacity as soon as possible.
