# Unveiling of QR code signs

Last Wednesday 19 February, Her Worship the Mayor and Elected Members shared a small, yet special occasion with residents of Tiwhatiwha Crescent and Piripiri Crescent.

The residential developments by Council in these areas lead to new street names being required which were gifted by Tangata Whenua via Tūwharetoa Kaumātua and Council's lwi Liaison and Cultural Advisor Te Haukakawa (Boycie) Te Rire.

There were some initial queries about the literal meaning of Tiwhatiwha and Piripiri and so the correct meaning and the small QR code below each of the street naming signs, takes readers to this correct translation captured on the Council website.

Kaumātua Te Haukakawa Te Rire welcomed Her Worship, elected members, residents and council staff and then carried out a karakia (blessing) of each of the codes. They were then unveiled (respectively at each location) and the website information read to all those attending.

It was a memorable occasion in that the whakapapa of both names were shared by Kaumātua Te Haukakawa Te Rire and the connection from the history of Tangata Whenua through to the names of the signs for today's residents was evident.

A shared cup of tea was then enjoyed by guests and residents at Porritt Glade Lifestyle Village.

Tūwharetoa Kaumatua and Council's Iwi Liaison and Cultural Advisor Te Haukakawa (Boycie) Te Rire completing the mihi and karakia of the information sign.

The unveiling of the Tiwhatiwha QR information sign and reading was completed by resident Lynn Vowles with support by Her Worship Mayor Tunui.

Piripiri's sign was unveiled by residents Russell Chase and Ben Rickard and followed by Mayor Tunui's reading of the meaning.

# Maintenance on the Rec Centre

Last year, Council completed an assessment of the Ron Hardie Recreation Centre foundations which were given a solid green light by engineers.

Now we know the building has a longerterm future, we are completing further maintenance to complete the water tightness of the Rec Centre. This includes work on the flashings, gutterings and repainting another coat on the roof.

Our goal is to get the centre back up to a good standard, so we can increase usage of this multi-functional facility. The Rec Centre is ideal for indoor sporting events, exhibitions and large entertainment functions such as the Rangitaiki Kapa Haka Festival proudly hosted in Kawerau in late 2024.

# Steam pipe update

Recently Hutec replaced the steam pipe from the bore to the pump shed, at the Maurie Kjar Aquatic Centre. Hutec installed a new pipe, which they manufactured offsite and coated with a special protective layer against sulphur corrosion.

The steam pipe replacement was part of the ongoing maintenance programme at the Maurie Kjar Aquatic Centre. This replacement should keep the pools warm all winter!

# **Upcoming Gambling Policy consultation**

On Wednesday, 26 February, Council discussed the report outlining the proposed review of the Gambling Policy which aims to reduce gambling harm in the community.

Since 2017, Kawerau has had a 'sinking lid' policy on the number of gambling machines permitted in Kawerau. This has reduced the total number of gambling machines from 54 to 36. Also, the number of gambling venues has reduced, halving from four to two venues in the same period. The report included a social impact assessment received by the community on request by the Council in late 2024, which outlines there is a high risk from gambling harm in the district.

Council has resolved to merge the Gambling Venues Policy and Board Venue Policy and ensure the focus remains on reducing gambling machine numbers. At the 26 March Council Meeting, the draft policy will be tabled with Council and then we will be asking the community for your feedback.

Consultation will be carried out from 31 March to 5 May 2025.



# **Easter Trading Policy consultation open**

Submissions for the Draft Easter Sunday Shop Trading Policy are now open. The purpose of the policy is to allow shops in the Kawerau district to open on Easter Sunday.

Kawerau District Council's previous Easter Sunday Shop Trading Policy has been revoked. This consultation asks the community and local businesses if they would like to reinstate the policy.

Council is aware that over the Easter weekend, more people are entering the district, to visit, shop and stay. Currently, Council does not have a policy, that allows shops to open on Easter Sunday. This means only businesses that comply with section 4, of the Shop Trading Hours Act 1990, can open on Easter Sunday. This is a disadvantage for other local businesses, who may wish to trade on the public holiday.

Please note, if this policy is adopted, it will give shop owners the choice of whether they want to open or not. Employees are not obliged to work, as it is a public holiday, it is up to the employee's discretion.

# **Recycling Update**

Summer is always a peak period for kerbside recycling and we wish to thank our community for your patience and our team for their work.



Solid waste is one of the biggest costs to the community and increasing our recycling efforts can significantly decrease the volume of waste sent to landfills.

This reduction leads to lower landfill fees and related solid waste disposal levies imposed by regional/central government, which can result in substantial savings for our community.

In addition, Council is looking to implement effective recycling practices and streamline our waste management processes.

You will have noticed we are trialling changes to our collection process including that our team is nowsorting recyclables at the kerbside to increase efficiency.

By sorting recyclables more efficiently, we can reduce the number of man-hours required for waste sorting and other areas of the operation.

### What Can I Recycle?

In Kawerau, you can recycle plastics numbered 1, 2, and 5, cans, tins, glass jars and bottles, paper, and cardboard. Remember, you can still sort your recycling separately by squashing down and neatly bundling paper and cardboard. Glass bottles and jars can be placed in the crate in the box they originallycame in.

Please ensure that all items are rinsed, and food scraps and lids are removed before recycling.

Only the recyclable items listed below will be picked up from your recycling crate.

### What if items are left in the recycling crate?

Our recycling team will only collect what can be recycled. If items are left, you should also receive a note to advise what can be recycled. The aim is to improve recycling practices in our district and provide a more efficient and effective way to collect and sort recyclables.

# Road maintenance ALL GO!



Council has been busy improving roads and footpaths around our district. This is a planned programme of works and we appreciate the patience of the community for the disruptions.

One of the notable jobs that has been completed was the replacement of the speedhump on

Onslow Street. Fixing the speedhump allows safer access for children arriving to and from Kawerau South School. Currently, Council is rebuilding the access way into the Water Pumphouse Station along River Road. This work is expected to take two weeks. This road is well used. Rebuilding the road will allow safer access to the drinking water taps.

Other jobs that Council is doing that involve road closures are rebuilding roads, replacing waste water (sewer) pipes, completing road treatment work and installing underground cabling. Council acknowledges the work can take longer than expected and we appreciate the inconvenience for our community. These contracts are tendered with detail and performance conditions to ensure Council and the community are getting the best value for money.

# **Repairs on Town Hall Roof**

We wish to advise our community that there is likely to be some disruption and access restrictions in the Ranfurly Court, Tarawera Mall entrance area in the coming month from Wednesday 5 March.

We are completing some much-needed roof repairs and replacements on a section of the roof from the Council Office's main entrance along to Town Hall roof. We have engaged a qualified contracting company TyS Asbestos as the roof material may contain asbestos (as was standard for buildings of this age).

The repair work will be carried out between Wednesday 5 March and Friday 4 April.

Notice has been given by the contractor to local shops and businesses in the area and we expect minimal risk to the community. Should there be issues, the contractor will ensure that shops and businesses are made aware and that pedestrian access will be restricted to the Ranfurly Court area which will of course, may include the children's playground.

# Safety at Maurie Kjar Aquatic Centre

The Maurie Kjar Aquatic Centre is a great place to bring your whānau all year round.

Please remember, children must be supervised by their parents or caregivers at all times, when they are in or around the water at the centre. A child can drown in less than 60 seconds. If you are bringing your child to the pools, it is the responsibility of the parents or guardians to actively supervise them at all times.

Lifeguards are present to ensure overall safety, however, the primary responsibility for watching over children lies with the parents and caregivers who brought them to the pool.

# For your whānau's safety at the Maurie Kjar Aquatic Centre please ensure:

- Children aged five years old or younger are within arm's distance, at all times (you can reach them)
- Children aged between six and eight years old are in your sight, at all times
- Children eight years old or younger must not be left in any pool unattended
